1st IFRS 16 application

IFRS 16 standard "Leases" is applicable since 1 January 2019. The financial statements are now presented using this standard.

In accordance with the simplified retrospective method chosen, the Group does not restate comparative periods.

In order to present comparable figures, column "June 2019 (6 months) excl. IFRS 16" shows results without IFRS 16 application.

Disposal of Mediamobile entities

On 15 November, 2018, Mediamobile France and Mediamobile Nordic entities were sold. The Mediamobile subgroup remains included in the 2018 figures until its effective disposal date.

Column "June 2018 restated (6 months) excl. IFRS 16" shows Group results excluding the contribution from the Mediamobile subgroup.
